## **MINUTES**

## **FEBRUARY 8, 2021**

- OPEN MEETING The February 8, 2021 BCA Meeting was opened by Selectboard Chair. Frank Sawicki, Jr at 5:30PM. The meeting was held via ZOOM. - 2. ELECT A CHAIRPERSON On a motion by Gregory and seconded by Renee, Frank Sawicki, Jr. was elected Chairperson for this BCA Meeting.
- 3. REVIEW NEW APPLICANTS SINCE LAST MEETING Board reviewed new applicants as well as purged voter lists. Noreen explained the majority of the purged voters were voters who had received challenge letter and not responded since two general elections had passed. Renee questioned one voter who had been added stating that this person lives in NH. Noreen explained that her mother lives in Canaan and that is the address she used at the time of her application, which was on voting day.
