CANAAN FIRE DISTRICT #1 MONTHLY MEETING AGENDA/MINUTES September 20, 2017

- OPEN MEETING The September 20, 2017 Canaan Fire District #1 monthly meeting opened at 7:10PM. Those present: Norman Labrecque, Jeffrey Richards, Noreen Labrecque, April Busfield. Jeremy Labrecque and Dave Ceppetelli via conference call.
- 2. Paul Thibault came in to show the board pictures of his water filters. The board stated that they have plans to get Holmes Street done as soon as they get word from USDA about funding. April explained that once the Water Treatment Facility is in operation there should be a significant drop in manganese and iron which is causing all the sediment in the system. Unfortunately the more we use the well the more minerals will be present.
- 3. **APPROVE MINUTES** AUGUST 16, 2017 On a motion by Norman and seconded by Jeff the board unanimously approved the minutes.
- 4. ADDITIONS/DELETIONS- None

5. REPORT FROM OPERATOR

- A. Filling tank April explained all the issues that arose while filling the tank. She stated that she was not in favor of the method that was used and consequently we had several complaints and issues.
- B. Pressure release valve Stewartstown Because of the increased pressure with filling the tank Tata and Howard had Gosselin install a pressure reducing valve at the meter house for Stewartstown. Unfortunately it reduced the pressure too much once the pump was turned off and the Trailer Park was without water. Bill Allen removed the valve and Tata and Howard have designed a by-pass to be used before the new storage tank comes on line since that will again increase the pressure which could potentially cause more leaks to Stewartstown's already tender pipes.
- C. April then described the disrespectful treatment she received from Bill Allen while trying to help at the meter house. The board advised her not to help him if he is going to act that way. If Canaan FD#1 is the one paying her salary she has no obligations to Stewartstown besides supplying water to them to the valve before the meter house......after that it is all their responsibility.

In order for the new tank to go online the old tank needs to be abandoned and isolated. The telemetry system will need to be in place at that time as well.
