- OPEN MEETING The Canaan Fire District #1 monthly meeting opened up at 6:01 PM. Those
 present: Norman Labrecque, Jeremy Labrecque, April Busfield, Noreen Labrecque, Gary Leach.
 NOTE: Canaan Fire District #2 also present.
- ELECT A CHAIRMAN FOR THE PRUDENTIAL COMMITTEE Norman Labrecque nominated Jeffery Richards for Chairman for the 2018 year. The nomination was seconded by Jeremy Labrecque and approved by the board.
- 3. APPROVE MINUTES NOVEMBER 15, 2017 On a motion by Jeremy and seconded by Norman the November 15, 2017 Monthly meeting minutes were approved.
- 4. REPORT FROM OPERATOR No report
- 5. TATA AND HOWARD
 - A. TELEMETRY PROPOSALS Gary Leach explained that only one proposal was received for the telemetry system. They sent out four requests for Proposals with only one response form Electrical Installations Inc. The initial proposal from EII for Fire District #1 was \$68,510.00 but Tata and Howard was able to negotiate the price down to \$59,900.00. Gary explained that once USDA has reviewed and approved the project can be awarded. On a motion by Norman and seconded by Jeremy the board approved the \$59,900.00 proposal pending approval from USDA.
 - B. UPDATE ON PROJECTS- Gary stated that they are finalizing all concerns in writing to the State Water Supply with regards to the Treatment Facility and are hoping to get the Permit To Construct so this project can go out to bid. Their estimated cost for the Treatment Facility is \$1,200,000.00. Gary informed the board that they will probably need to call a special meeting before the next monthly meeting for this project.
