## TOWN OF CANAAN PARKING BANS



Effective December 1, 2016 through April 1, 2017 it is unlawful to park between the hours of 11:00 p.m. and 7:00 a.m. on all streets and roads in Canaan and Beecher Falls (this includes Town Roads and Vermont Routes 102, 114 and 253).

## SNOW REMOVAL

No person, other than an employee in the performance of his or her official duties as authorized by the Agency of Transportation or the Selectboard, shall plow onto the traveled way, shoulder or sidewalk of a State Highway or a class 1, 2 or 3 Town Highway (V.S.A.T23 Section 1126a.)

## NOTICE TO RESIDENTS

The Canaan Selectboard would like to remind town residents that, despite the best efforts of the town road crew not to do so, sometimes items within the town highway right-of-way get damaged, either by snow removal or other highway maintenance equipment. The town is not responsible for damages obtained within this 25 foot from center of road. The Selectboard is asking that residents beware before leaving or placing objects such as vehicles, fences, trees, signs, etc. within these boundaries. Objects may be removed at the owner's expense.

### VERMONT ELECTION LAWS

Vermont Election Laws no longer require Vermont Towns to hold a yearly nomination caucus: The sole purpose of which is to have a candidate for each vacant office.

Interested candidates wishing to run for election as a Town Official must get a petition at the Canaan Town Clerk's Office. The petition must be signed by 1% of the legal voters of the Town of Canaan. (This is about 6 signatures)

#### SolidWaste Review

We recently had a site visit by the Agency of Natural Resources and overall we were in good shape. They do site visits for all transfer stations. We did not have our current Certification to Operate posted at the transfer station office. This has been corrected. We will need to provide better containers for our CFL light bulbs. These will be ordered. We do not separate our e-waste due to space constraints. We will need to label boxes as mixed e-waste. If we sort our e- waste we could get \$.05 per pound. We will be reviewing and if we can we will sort. He also suggested an outlet for our collected batteries. We will be looking into both suggestions.

## **Illegal Dumping**

We have had someone who is using the transfer station when it is not opened. This is considered illegal dumping and subject to being fined. Dropping waste of any kind or recyclables is not allowed when the transfer station is not open. When bags of household waste is dropped off when we are not open the bags get ripped apart by birds and other critters creating a big mess that we have to clean up. Just because the gate to the transfer station and treatment plant is open doesn't mean we are open for business. The sign posted at the gated entrance has the days and time that we are open. We will be investigating to find out who is doing the illegal dumping and charges and fines will be levied.

## **Utility / Back Up Person**

The Selecboard after several years discussing the pros and cons about hiring a Utility/ Back Up Person has hired Brian Bissonnette to fill this position. Brian has been working part time on the water and sewer systems and other jobs as well. Kenny Rogers who was working with Richard on plowing the roads for the winter months has decided to call it quits. You may have already seen Brian out on the roads plowing. You might question why do we need a full time employee as opposed to a part timer? We discussed this option of part time and it proved difficult to find someone willing to work part time who would have all the skills to meet all the requirements of the jobs we expect them to be qualified in or licensed to perform and be available when we needed them. Some of the jobs we currently bid out will be filled by Brian. There are situations where we are required to have two people on site so that we meet the labor rules for safety. We need qualified back up personnel when someone is ill etc. Brian's time will be charged back to the department that is using his time. Example: Sewer, Water, Transfer Station, Highway, Parks. We chose Brian because he already has some of the skills that we needed and has been working part time for the town.

## Canaan FD#1 Updates

There are several projects as part of CFD#1. Here are some updates for those projects for the report:

<u>CFD1,Contract #1</u> – Contract #1 entailed the construction of new water mains and service line connections that was seen throughout 2016. The project is complete with all the newly installed water mains and services are as you may know operational.

<u>CFD1,Contract #2</u> – <u>Rail Trail Water Main Connection to CFD#2</u>. The permitting of the project through the NH Department of Recreations and Economic Development has held up the project from being completed in 2016, and now will be completed in 2017. The project ties the CFD#1 system to the CFD#2 system along the abandoned railroad bed now used as a ATV/snowmobile trail. The project will be bid this winter.

CFD1,Contract #3 – Water Storage Tank: This project's permitting and design has been completed and will be bid this winter as well. Construction will begin in the Spring of 2017. The project includes a new 200,000-gallon water storage tank with a 1800 foot 12-inch water transmission main to the new CFD#1 water main at the VT253 / Powerhouse Road intersection. The new tank will increase pressures in the water system and along with the new piping provide fire protection.

<u>CFD1,Contract #4</u> – <u>Water Treatment Facility.</u> The water treatment facility which is to be located adjacent to the well located off Ethan Allen Drive will remove iron and manganese from the water. Also a pilot study to confirm the size and equipment required to treat the well water was completed in early December. The project will be bid in late spring or early summer depending on permits from the State of Vermont and construction is expected to begin in late summer of 2017.

<u>Canaan FD#1- Contract #5-</u> The District is applying for a grant from USDA for upgrading the water meters, installing a radio control system for the storage tank, well and treatment facility, some short water main replacements and miscellaneous work.



#### CFD2 - Water Main Relocation

The Water Main Relocation Project was completed in November, on time and under budget. The 8" water main that is hung beneath the Bridge St. bridge above the Connecticut River is no longer conveying water from VT to NH and vice versa. The new 10" HDPE water main that was drilled beneath the CT River is now handling those duties. The abandoned water main will be removed by the NHDOT contractor as part of their bridge refurbishment project in 2017.

## Canaan Town Receives an Ownership Dividend Credit from Its Self-Insurance Association

Selectboard of Canaan Town announced today that the Town of Canaan has received \$1,232 as a contribution offset from the VLCT Property And Casualty Intermunicipal Fund (PACIF), the non-profit organization through which Canaan Town obtains its Property/Casualty and Workers' Compensation coverage and risk management services. Each year the PACIF Board of Directors, comprised of local officials, considers the past success of the Fund and determines if any monies can be returned to the membership. This year the PACIF Board voted to return \$500,000 to the members as contribution credits and \$200,000 in loss prevention equipment grants for a total of \$700,000. Since the inception of the Fund, PACIF has returned a total of more than \$18 million to its members.

"\$1,232 has already been subtracted from our 2017 invoice," says Selectboard. This credit is as valuable as if the Town of Canaan had received a check made out for the same amount.

Canaan Town received the \$1,232 credit as a member-owner of the VLCT Property and Casualty Intermunicipal Fund (PACIF), an intermunicipal self-insurance association operated on behalf of its members by the Vermont League of Cities and Towns (VLCT). This year's distribution comes from the net position from specific prior fund years. It was deemed available to be returned to members by the Fund's consulting actuary and was approved by the Board of Directors.

"VLCT PACIF is one of the best examples of successful intermunicipal cooperation that exists today," says Ken Canning, Director of Risk Management Services for VLCT. "It was formed in 1986 when several of Vermont's cities and towns appealed to the League for assistance because their insurance companies were restricting coverage and raising prices exorbitantly high or dropping municipalities completely. Since then, PACIF has become the preeminent provider of municipal coverage and has responded to its members' needs by enhancing coverage, handling claims professionally and fairly, and providing extensive risk management support and consultation."

#### What is SASH?

SASH (Support And Services at Home) is part of the Blueprint for Health, Vermont's statewide health care reform initiative.
SASH helps Vermont's most vulnerable citizens, seniors and individuals with special needs, access the care and support they need to stay healthy while living comfortably and safely at home.

SASH is available in many communities throughout Vermont and serves primarily persons 65 and older and persons with disabilities. *Participation is voluntary and free of charge.*SASH communities include a care coordinator and wellness nurse who work in partnership with a team of community providers to assist SASH participants.

#### Only Six Weeks Left to Sign Up for January Health Coverage

Department of Vermont Health Access officials reported that Vermont Health Connect Open Enrollment has been progressing smoothly. They expect the state to maintain one of the lowest uninsured rates in the country in 2017.

Open Enrollment is a time for new customers to sign up for health and dental plans for the coming year. It is also a time for current customers to compare their existing health plan to other options. Vermont Health Connect offers a free 2017 Plan Comparison Tool, which can help customers decide whether another plan would be a better fit for their family's needs and budget. The online tool allows customers to compare plans not just by monthly premiums and deductible amounts, but also by estimated total annual costs. Vermonters can try it out by clicking on "Decision Tools" at <a href="http://bremontHealthConnect.gov">http://bremontHealthConnect.gov</a>.

After taking a couple minutes to enter age, income, health status, and expected use of medical services for all family members, the site presents the 20 qualified health plans from Blue Cross Blue Shield of Vermont and MVP Health Care in order of estimated total costs, lowest to highest. Users then have several options for sorting the results, or they can click on links to plan details and additional information on insurance carrier websites.

Vermonters who would prefer to talk to a live person about their options can call Vermont Health Connect's toll-free Customer Support Center at 855-899-9600 or set up an appointment with an Assister in their community.

Vermont Health Connect encourages Vermonters to take note of the following dates:

December 15 - Last day to sign up or report change for January 1 coverage

December 26 - Payment due for January 1 coverage

January 15 – Last day to sign up or report change for February 1 coverage

January 31 – Open Enrollment ends (coverage effective March 1)

Customers with online accounts can sign in to report changes and pay their bill from 5am until 1am most days. Due to scheduled system updates, customers won't be able to access their online accounts from 8pm tonight until 5pm tomorrow (Saturday). The Plan Comparison Tool and all information on the Help Center site will continue to be available. This weekend's maintenance period will not impact the Vermont Health Connect's call center, which is open 8am to 8pm Monday to Friday.

Vermont Health Connect's 2017 Open Enrollment began November 1 and runs until January 31. New customers can sign up online, by phone, or in person with an Assister. Current customers are automatically being renewed into 2017 coverage; they are able to call 855-899-9600 or click on the Renewals link in their online account to report changes for the 2017 coverage year.


