TOWN OF CANAAN PARKING BANS



Effective December 1, 2021 through April 1, 2022 between the hours of 11:00 p.m. and 7:00 a.m. it is unlawful to park on all streets and roads in Canaan and Beecher Falls (this includes Town Roads and Vermont Routes 102, 114 and 253).

SNOW REMOVAL

No person, other than an employee in the performance of his or her official duties as authorized by the Agency of Transportation or the Selectboard, shall plow onto the traveled way, shoulder or sidewalk of a State Highway or a class 1, 2 or 3 Town Highway (V.S.A. T23 Section 1126a.)

NOTICE TO RESIDENTS

The Canaan Selectboard would like to remind town residents that, despite the best efforts of the town road crew not to do so, sometimes items within the town highway right-of-way get damaged, either by snow removal or other highway maintenance equipment. The town is not responsible for damages obtained within this 25 foot from center of road. The Selectboard is asking that residents beware before leaving or placing objects such as vehicles, fences, trees, signs, etc. within these boundaries. Objects may be removed at the owner's expense.

REPORT FROM THE SELECTBOARD

We hope everyone had a good Thanksgiving and will have a Merry Christmas along with a safe and Happy New Year. We welcome Mark Bullard to the Selectboard and wish him the best. Elections will be coming up in March and we have already started to see sign-ups for items to go on the warrants for Town Meeting on the table at the Town Office. This coming elections there will be a one year and a three year position for the Selectboard. It behooves those who are interested in running to attend a Selectboard meeting or two to see what is going on and if it is for you. It is more than just a meeting every two weeks. We have quarterly meetings with Stewartstown for the sewer committee. There is also dispatch and meetings at the County for recycling. Any emergencies that come up, we meet to make sure that things are being done in compliance with State rules which change every time the wind changes directions. This time of year we are putting the budgets together for the upcoming year and this year fuel costs are going to be the driving factor on a good portion of the budget.

Contractors and residents doing big renovation jobs or disposing large amounts of debris need to rent their own dumpsters since the container at the transfer station has limited space and it is not fair to other residents in town who have a small amount of items and cannot dump because the container has been filled up with your debris.

VERMONT ELECTION LAWS

Vermont Election Laws no longer require Vermont Towns to hold a yearly nomination caucus: The sole purpose of which is to have a candidate for each vacant office.

Interested candidates wishing to run for election as a Town Official must get a petition at the Canaan Town Clerk's Office. The petition must be signed by 1% of the legal voters of the Town of Canaan. (This is about 7 signatures)

The petition form must be submitted to the Town Clerk's Office no later than 5:00 p.m. on January 24, 2022. If you are interested in seeing someone's name on the ballot, please do not hesitate to pick up a petition.

(For example, Rick "Speedy" Driver is o.k., but you cannot use Dr. Rick Driver.)

*This is not allowed in most towns. Leave blank unless your town has complied with the following state law: No political party or other designation shall be listed unless the municipal charter provides for such listing, the town has voted at an earlier election to provide such a listing or, in the absence of previous consideration of the question by the town, the legislative body decides to permit listing. If political party or other designations are permitted, no candidate shall use the name of a political party whose certificate of organization has been filed properly with the secretary of state unless the candidate has been endorsed by a legally called town caucus of that political party for the office in question. In any event, the candidate must still file the petition and consent form required by section 2681 of this title. 17 V.S.A. §2681a(d).



Charleston Water System class-action lawsuit against 'flushable' wipe makers given preliminary approval from federal court

The federal district court in Charleston, South Carolina, has given preliminary approval to a proposed <u>Class Action Settlement</u> between Plaintiff Charleston Water System and Defendant Kimberly-Clark Corporation ("Kimberly-Clark") addressing Kimberly-Clark's flushable and non-flushable wipe products.

The settlement does not affect any potential individual claims against wipe manufacturers for damages or other monetary relief due to wipes-related blockages. However, if approved, Kimberly-Clark will implement certain modifications to its business practices with respect to flushable wipes, as well as labeling requirements for non-flushable wipes, and Settlement Class Members will release any and all claims for injunctive relief they may have against Kimberly-Clark arising from or relating to Plaintiff's allegations. Owners of wastewater treatment plants/systems should review this settlement as their legal rights are affected whether or not they act.

"We believe the settlement is outstanding in terms of ensuring that Kimberly-Clark's Cottonelle Flushable Wipes will meet a national municipal flushability standard for flushable wipes and Kimberly-Clark will provide much improved notice on its packages of non-flushable wipes that such wipes should not be flushed. In combination we believe this settlement will significantly reduce collection system impacts from Kimberly-Clark's products, and eventually other manufacturers' products, given that this settlement will set a precedent/standard for the rest of the industry."

With the passing of 2021 and the coming of 2022 we can only hope things get better. We have only one project that we need to work on and more news about that will hopefully come in the next newsletter.

Recently Marc Dion, at the transfer station, salvaged an old photo that he passed on to us. It was about 33 by 8 inches and featured a large group of well-dressed men and women standing in front of a couple of buses in Toronto. It was dated 1927 and titled "The Vermont Special". Some research found that it was a special train outfitted by the State of Vermont that traveled around the Midwestern U.S. and Canada. Products, exhibits, and representative from the state and all counties of Vermont were part of the tour to bolster tourism in the state. Products from the Beecher Falls Furniture Company, fish and animal exhibits from Quimby's and representatives from Marshall's Cabins were all mentioned in a story in the March, 2020, Northland Journal written by Sylvia Dodge. I have contacted the Vermont Historical Society to see if they have a list of the representatives from Canaan, whom I hope to identify in the picture.

One of our late-season visitors was a lady who has a cottage on Averill Lake. During the tour she discovered the glass-plate negative project I am working on and expressed an interest in writing an article for the Seven Days Vermont newspaper, for whom she works. She hoped to have it completed in December and promised to send us a copy. She wanted some of our photos of the project but no photographer was available on short notice so she contacted the Colebrook Chronicle. They were nice enough to send her some photos to include in the article. The article was published in the December 8 issue so I read it in the on-line edition. It was a positive for us, despite a couple of minor discrepancies. Any publicity is better than none and may result in more visitors next year. Our thanks to Seven Days Vermont for writing about us.

Here's hoping 2022 is a prosperous and healthy year for us all.


