## 2019 Canaan. Naturally Connected, Inc. Overview:

- The team reviewed the overview that was created prior to the Challenge Meeting at Burke, with a few other items added. Correction to be made on the document is to change the word "encouraging" to "Working with" on the 2<sup>nd</sup> to last bullet of accomplishments.
- The group decided that what was on the overview was a good summation of what Canaan's Heart & Soul/Canaan. Naturally Connected has accomplished as well as including the 5 value statements.
- The handout will help when creating the End of Year Review for communication purposes, grant writing, and Town Meeting article request.

# Revamped short/long term project lists:

- A short term project list and a long term project list was compiled by going through all of the minutes since January 2016.
- Observations that were made while going through the information were:
  - CNC should have a monthly column in the local newspapers to inform the public of what the group has accomplished, presently working on, and the next few projects in the future. All in favor.
  - CNC needs another way to display our banner at functions. Research into a display holder and the purchase of a smaller banner will be needed. All in favor.
  - CNC needs to be more cognizant of obtaining pictures of community events that we are involved in as well as have a photo disclaimer available on any sign-up sheets (can be obtained via Google per Steve. All in favor.
  - CNC needs to track people's in-kind hours (including our own) and money donated for grant writing purposes (matching). Les is going to forward to Terrie what he has for our use in the future. All in favor.
  - CNC should have an After Action Report after our events/events we are involved in. All in favor.
  - Terrie needs to catalogue all of CNCs items appropriately, through all of Base Camp and organize items downstairs at the Town Office. All in favor.

- Items in the Town Office should be relocated at the Grace Community Church parsonage. All in favor.
- Corrections to be made on the long term project document: "homeless shelter" to read "temporary housing"; add "Pioneer Trail" before "build a gazebo..."
- The current short term projects that are in progress are:
  - Welcome signs; April Lemay and Christine Cote are working on this project. They will be working with Mike Furbush; we will need 4 signs for Canaan and 1 sign for Beecher Falls. We will ask the town select board if Richard Thibeault would be able to put the new signs in. Angie will verify but the Canaan Schools Class of 2020 might donate money towards this project.
  - Fletcher Park beautification remains on-going with the refurbishing of the fountain . A community-wide/school competition of a mosaic tile design for the bottom of the fountain, as well as the side of the base, will be put forth. More research needs to be made on the type of tile used, temperature maxiumum and minimum to avoid cracking, and cost.
  - Create more community gatherings
- The current long term projects that are in progress are:
  - Pioneer Trail/gazebo in Beecher Falls park. Greg and Steve Ellis need to meet to know Pittsburg's process for theirs went. Angie brought up that perhaps a local Eagle Scout would be interested in the gazebo project? Will need to be looked into for information.
  - Cultural Destination
  - Coffee shop
  - > Non-motorized vehicle trails and maps

# Old Business:
