#### **DOG LICENSES**

If you no longer own your pet contact the Town, so your name will be removed.



#### CLEANUP OF EXCREMENT

Responsibility for cleanup of excrement. The owner of any animal shall be responsible for the prompt removal of any excreta deposited by his or her animal(s) off the owners premises. Failure to remove such excreta shall be considered a violation of the ordinance.

#### **LEASH LAW**

Responsibility for Leash Law: "At large" shall be intended to mean off the premises of the owner, and not immediately under the control of the owner or a member of the immediate family either by leash, cord, chain or otherwise. Failure to follow the leash law shall be considered a violation of the ordinance.

#### TOWN MEETING

Another Town Meeting is behind us and the Selectboard wants to thank all who attended and offered their support for the 2017 budget. We also want to thank the Class of 2020 for providing a great meal before the Town meeting.

The Town is privileged to have many volunteers who give many valuable hours to make the town a safer and better place to live. We thank all the volunteers for their generous help.

#### **PROJECTS**

There were several projects that we overlooked to mention at the town meeting:

## Project 1. Improving Efficiency in Municipal Street and Pubic Space Lighting

This program is designed to encourage municipalities to re-evaluate the present use of older less efficient lighting technologies for street and public spaces. We will be considering the benefits of replacing with more efficient LED Lighting Systems. One component of the program is to review all current lighting fixtures on poles and see if any of them could be turned off and taken out of service. A thorough review will be done with safety in mind. There appears that there are some that could be turned off without creating safety issues. We are working with Vermont Efficiency to complete this project. We will also be looking into the possibility for Solar Energy for the wastewater treatment plant and transfer station. We will be looking into the feasibility of solar panels on the utility poles that would generate power back into the grid. This could be a pilot program for Canaan.

## Project 2. Creating Designated Village Centers for Canaan and Beecher Falls.

Village center designation supports the revitalization efforts of medium sized historic centers. The designation brings financial incentives, training and technical assistance needed to attract new business and vitality to Vermont's smaller communities. Our new town plan helps us meet the requirements for this program. The Town Planning Board and Selectboard will be meeting with Irene Nagle of NVDA and Richard Amore on April 7th, 2017. Richard Amore represents the VDVCP and will be reviewing the potential village destination centers for Canaan and Beecher Falls. There will be a meeting with business owners that same day. This will be for business owners within the potential designated area. They will be notified of the place and time of the meeting.

## Community Revitalization Heart & Soul Update

- 1. We were awarded a \$22,000 grant from the Tillotson New Hampshire Charitable Foundation to cover Phase 111 of our CRHS. We thank and appreciate the trust and commitment the foundation has in our efforts to continue with the process of bringing positive change and involvement in ways to make Canaan a vibrant and connected community going forward creating a positive outlook that we collectively can make a difference for positive change without changing what we treasure as our community.
- 2. One of the projects that we have identified that would be helpful for our aging population was senior housing. We have been working with Rural Edge. Representatives for the organization have toured our town. We have gotten positive feedback from them. Having said that there are always hurdles to overcome. We will continue to pursue this opportunity.

#### PROJECTS CONT'D

- 3. We recently got news that SASH will be providing a part time coordinator for the Norton/Canaan area. Her name is Christine Wheeler and duties start 3/27/17. SASH is also part of Rural Edge a Community Development Corporation.
- 4. So what is SASH?
  - a. Establishes trusting, supportive relationships with residents that builds upon their current support systems and enhances their opportunities for care and stability in the coming years.
  - b. Build relationships with elder care professionals that will lead to formal partnerships in the SASH program.
  - c. Develops and collaborates with a team of volunteers that will provide services and activities for seniors in the program.
  - d. Bring services to seniors at all income levels and health stages
  - e. Applies evidence based practices in a Community Healthy Aging Program.

## **Updates on Canaan Fire District #1 Projects**

The Canaan Fire District #1 has gone to bid with Phase 3 of the 4 phases for the Water System Improvement Projects. This phase consists of a 220,000 gallon water storage tank that will be located on the Canaan Forest Land off VT RTE 253 along with 1,600 LF of 12 inch water main connecting to the line that was installed last summer on VT RTE 253. To date no decision has been made on the chosen contractor for this phase of the project, however one is expected soon with construction estimated to begin around May 1<sup>st</sup>, weather dependent. As with all prior projects, we ask for your cooperation and patience with the extra traffic and possible delays in travel through the village of Canaan. Phase 4, the water treatment facility, is currently being designed and is expected to be out to bid by the summer of 2017.

Additionally, the District, based upon the findings during Phase 1 that replaced the vast majority of the water mains and services, is planning to upgrade the water mains on Nathan, Enid and Holmes Street in 2018. In addition, we are planning to replace all of the water meters by 2018.

## Chlorine Odor in Drinking Water

There have been complaints about chlorine in our water systems in both Canaan and Beecher Falls. We try our best to keep the chlorine level at a point that keeps our consumers happy and meets state requirements which are more stringent than that of Federal EPA requirements. The US Environmental Protection Agency (EPA) requires treatment facilities to maintain a chlorine residual level that is chemically detectable but no greater than 4 mg/l. Four milligrams per liter is the "Maximum Residual Disinfectant Level" for chlorine, and it is the level below which there are no known or expected risks to health from exposure to the disinfectant. At this time the State of Vermont Department of environmental services has more stringent requirements. FD1 is required to have a minimum residual in the distribution lines of .30 mg/l which may change after the completion of upgrades and the removal of the springs which require constant chlorination. Because of the proximity to the river FD2 is required to have a residual of .5 mg/l in the distribution line. Currently at the wells and reservoirs we are trying to have the residual chlorine be somewhere between .6 and 1 mg/l averaging at .75 mg/l. By the time the water reaches the furthest point of the system the level is very close to the minimum requirement.

The chlorine odor of tap water can be traced to the chlorine "residual," a low level of chlorine maintained in water to guard against bacteria, viruses and parasites, which may be in the water as it flows from the treatment plant to points of use. In the US, even treatment plants that use non-chlorine disinfection technologies are required to add chlorine to the water before it flows into the distribution system. The chlorine residual acts like a "body guard". Most people can sense a chlorine residual around 1 mg/l.

If your water smells more strongly of chlorine than others you are probably nearer the point of entry. Both treatment facilities feed water a long distance throughout the towns and into New Hampshire, requiring heavy chlorination to maintain a chlorine residual throughout the system. (The chlorine residual also may be raised by treatment facilities during warm weather when chlorine dissipates readily from water.)

If you are bothered by a chlorine odor to your water? Here are some practical solutions:

- •Install an activated carbon filter at your tap to eliminate residual chlorine in water safely delivered to your home.
- •Fill a pitcher of water and set it aside for several hours while chlorine dissipates. Transferring the water rapidly between two pitchers can accelerate chlorine dissipation.

## FROM THE HEALTH OFFICER

#### Bed Bugs, Should we be concerned?

It seems that in the last couple of years there has been a lot more talk about bed bugs and many people really do not know exactly what they are, some people will tell you that there is no such thing but that is not the case, they are real.

Bed bugs bite and some people react to the bites. When bitten, bites show on adults around the ankles and children on their back. They survive off of blood of warm-blooded animals which include people. Many times they go unnoticed.

To help prevent a bed bug problem keep your mattress covered, dry linens at a high temp for 30 minutes or sealed in a plastic bag in your freezer overnight, and through using pesticides. In some cases an exterminator is needed.

The health risk primarily is itchy skin from the bite.

## 2017 Town Meeting **Cell Phone Coverage Survey**


In 2014, the State of Vermont joined in a public-private partnership with a company called CoverageCo to increase cell phone coverage in rural parts of the state. After learning a lot about where people need coverage, we are now entering the next phase and we need your help!

We have provided a map where you will find the locations where CoverageCo currently has radios to fill in service gaps. You will know you are using one of the radios because the carrier on your phone will read "extension." A couple of items to keep in mind:

- The radios provide voice service for T-Mobile, Sprint, US Cellular and Verizon.
- Verizon doesn't allow data services on this part of the network and AT&T doesn't allow their phones to work on the network at all.
- Mobile virtual network operators (MVNOs) like TracFone, Republic, AARP, etc. cannot utilize the network due to their discount arrangements with their host carriers.
- · A cell phone repeater in a house or building will block the use of these radios. You might get better service if you are near a radio and turn off your repeater!
