# On Sunday, November 5, 2017 at 2 a.m.

This weekend is also a good time for everyone to take these steps to make sure their household is prepared for emergencies.

• Check smoke alarm batteries. When turning the clocks back, take a few minutes to push the test button to make sure the alarms are working. Replace the batteries at least once a year — if your model requires it. It's also a great time to check carbon monoxide detectors.

- •Install smoke alarms. If you don't have smoke alarms, install them. At a minimum, put one on every level of the home, inside bedrooms and outside sleeping areas.
- •Practice an escape plan. Make sure everyone in the family knows how to get out of every room and how to get out of the home in less than two minutes.

#### REPORT FROM THE SELECTBOARD

#### **Highway Department**

- 1. Completed the riverbank restoration on River Rd. and installed guard rails.
- 2. Completed the project of redirecting the stream to the culvert at the dry hydrant on Canaan Hill Rd.
- 3. Completed the Keyer Brook stream bank restoration.
- 4. Graveled 3 tenths of a mile on Hudson Rd.
- 5. Graveled section of Canaan Hill Rd. from Rte. 102 to the Fund Rd.
- Due to the fact we had to divert some highway funds to complete the top three items the wastewater treatment road paving will be re-scheduled to 2018.

#### Transfer Station

- 1. The container for the MSW has been repaired and back in use.
- 2. The C&D container has been repaired and back in service.
- 3. The concrete pad has been built for the metal container.

PACIF Inspection. (Property & Casualty Inter-municipal Fund Insurance) Purchased through Vermont League of Cities and Towns.

The following is a list of issues reported at the designated location and which need to be corrected.

#### **Transfer Station**

- 1. Space between tire storage container and metal container needs to be fenced off.
- Electrical power strips were connected in series. Too many extension cords connected to power strip device.
- 3. Stairway in recycling building blocked.
- 4. Eyewash was not in use.
- 5. Clutter in office.

#### Wastewater Treatment Plant

1. Needs a confined space program in place.

#### Town Office

One or more exit routes were blocked.

#### **Town Garage**

- 1. Blades for grader need to be stored off the floor in a rack.
- 2. If we allow the dirt pile for community use during the winter months we need a separate pile of dirt away from the main pile for community use and identified as such.

The selectboard has inspected the sites and reviewed all the issues with the operators and corrective actions have been implemented. Quarterly inspections will be scheduled with a check list to make sure all required safety issues are met going forward.

#### **Village Destination Centers**

Canaan and Beecher Falls have been mapped for Village Destination Status and we have been approved by the regulating board. This is an opportunity for businesses in the designated centers to get tax credits for starting a business or making improvements. Contact the town office for more information.

Selectboard: In order to complete some of the items on our to do list the selectboard will be working on these items on the weeks between our regular schedule meetings. The following is list of items we will be addressing.

- 1. Meeting Act 148 requirements to remove food waste from our waste streams.
- 2. Ordinances:
  - Town of Canaan Highway Access Policy
  - b. Blighted Properties (will include updating current junk yard polices)
- 3. Town Lighting (Switching to LED and taking some lights out of service). We will be placing a colored tape on the poles that we have determined could be turned off. This will allow for public comments on the lights identified to be turned off.

## Water Leak Statistics & Examples

Water use and especially unattended leaks can quickly add up to excessive water bills!

Give the town a call if you suspect a water leak at 802-266-3370.

The following shows the amount of water that can be lost for various size leaks.

#### A dripping leak consumes:

15 gal. per day 450 gal. per month

#### A 1/32 in. leak consumes:

264 gal. per day7,920 gal. per month

#### A 1/16 in. leak consumes:

943 gal. per day

28,300 gal. per month / At 60psi, a 1/16" hole leaks 74,000 gallons (9,850 cubic feet) in 3 months

#### A 1/8 in. leak consumes:

3,806 gal. per day

114,200 gal. per month / At 60psi, a 1/8" hole leaks 296,000 gallons (39,400 cubic feet) in 3 months

#### A 1/4 in. leak consumes:

15,226 gal. per day

456,800 gal. per month / At 60 psi, a 1/4" hole leaks 1,181,500 gallons (158,000cf) in 3 months

#### A 1/2 in. leak consumes:

60,900 gal. per day

1,827,000 gal. per month

#### Common water Loss examples:

Leaking Toilet @1/2 GPM = 21,600 Gal/mo

Watering Garden for 2 hours @ 5 GPM = 18,000 Gal/mo

Watering Garden for 2 hours @ 10 GPM = 36,000 Gal/mo

Unattended Water Hose 1 night @10 GPM = 5,400 Gal/mo

Broken Services Line 1 night @15 GPM = 8,100 Gal

1 day @15 GPM = 21,600 Gal

1 week @15 GPM = 151,200 Gal

1 month @ 15 GPM = 648,000 Gal

Stuck Ice Maker @ 2 GPM = 86,400 Gal/mo

Stuck Check Valve in Washing Machine – 30 minutes = 240 Gal

#### **Typical Normal Water Uses:**

1 Bath = 42 Gal

1 Shower = 17 Gal

Wash 1 Load of Clothes = 45 Gal

Flush Toilet = 3 Gal

#### **Chiefs Corner**

STOP

Be advised that the posted stop signs at the intersection of River Road and VT RTE 253 in Beecher Falls are still ACTIVE. Once the bridge is reopened your mind will be trained not to stop and that complacency could result in a serious crash causing injury or death. Be respectful of the construction workers present at this location who are trusting that the motoring public will stop and not drive through at posted limits. Violators will be subject to fines up to \$214.00 and 2 points on their license.

With the increasing number of motor vehicle complaints and recent spike in highway fatalities law enforcement agencies across the state are stepping up patrols and will be issuing more traffic complaint violations. We will be doing the same here in the towns of Essex County. If you see violations please report them. We all need to have a stake in keeping our highways safe.







# Is Your House Number Clearly Visible from the Street?

Seconds Count in an Emergency! That's why it's important that your house is clearly marked for emergency personnel. Simply put, ensure that assistance coming from any direction is easily able to identify your house number.

- Protect your family and your property by having large visible house numbers.
- Firefighters, police officers, and paramedics will be able to find you faster when your home is properly marked.
- A visitor, child, or injured person may be unable to give clear directions and rely on your house being properly marked. Emergency personnel from a neighboring community may be unfamiliar with your area.

## Use Large, Visible Numbers!

- The Office of the State Fire Marshal says "numbers need to be at least 4-inches in height and facing the street."
- Put the numbers under lighting, and use numbers with a contrasting background so they will be visible at night.
- Attach numbers to the home and NOT a door. Doors can be opened which will make the markings no longer visible.
- If your driveway is long, also post your house number on BOTH sides of a mailbox or sign pole at the end of the driveway near the road.

Be sure to keep the numbers visible by trimming trees and bushes.

The 45th Parallel EMS has 911 reflective signs available for purchase. They are made of highly visible materials that can be seen day or night. Up to 5 numbers can be placed horizontally or vertically for a variety of mounting options. The signs have predrilled holes for easy mounting, and installation advice and assistance is available. #### REMINDER—ZONING PERMITS

Property owners are reminded that a zoning permit is required for ANY land development including the "division of a parcel into two or more parcels, the construction, reconstruction, conversion, relocation or enlargement of any building or other structure, and any change in the use of any building or other structure, or land". Application forms are available either at the Town Office or from Bob Lee the Zoning Administrator.

# Northern Forest Center and Bourne's Energy Offering Low Cost Pellet Stove Packages to Essex County Residents

#### FD#1 PROJECTS

The Water Storage Tank project is ahead of schedule and is expected to be completed and online by year's end. Pressure and bacteriological testing is near completion and the 220,000-gallon concrete water storage tank is being backfilled. The contractor is expected to be demobilized from the project in mid-October. The new tank is at a higher elevation which will result in better water pressure. The fire hydrants will then be able to be used for fire protection once completed.

Meanwhile, the water treatment facility which will be located next to the well near Ethan Allen Drive design is in process. The facility will filter out both manganese and iron and the design plans for construction are being finalized by Tata & Howard to be submitted to the State for permitting within the next few months. Bids for the construction are expected in mid -Winter 2018 for a Spring 2018 groundbreaking. Final completion of the treatment facility is expected to be the Fall of 2018.

Additional water main replacement upgrades for Nathan, Enid and Holmes will be constructed in the summer of 2018 as well.



Reviews of the video have been mostly favorable and there has been discussion about producing a follow-up. Snippets were published on our Facebook page and received many positive comments. We plan to schedule a showing at the Coos County Nursing Hospital in the near future. A Sunday lunch at the Northland Hotel, to congratulate Alec Biron for his excellent work on the video, finished the project.

Our second Wallace Pond Memories session was held the 19<sup>th</sup> of August at Jackson's Lodge. We had about 35 attendees and all seemed to have a good time. Old Home Day in Pittsburg, the 20<sup>th</sup> anniversary memorial in Colebrook, and the George Van Dyke Pioneer Trail event in Hereford were all held the same day so we feel we did well.

Photographs and family albums continue to be loaned or donated to the historical society and many photos are scanned to our computer, labeled, and filed. The process is time consuming but rewarding as we continue to add to our photographic history of the town and its families.

This summer, as we have in the past, we provided background information and statistics for five alumni of Canaan Memorial who were to be inducted into the Orleans Northern Essex Hall of Fame. Twenty-two alumni have been inducted through the years and we are proud to have been instrumental in the selection process of most of them and writing the biographic sketches.

Our Facebook page continues to draw interest from former and current residents, their far-away relatives, and even people with no ties to Canaan. Check it out when you have time.

# Alice M. Ward Memorial Library

Our new two-year oral history project Canaan Histories kicks off this September. Funded by a grant from the Vermont Humanities Council, Canaan Histories will use newly purchased recording equipment to interview Canaan and area residents on key historical moments in recent history, such as the closure of the Ethan Allen factory in Beecher Falls, the return of veterans after wars, the Earth's People's Park in Norton, and others. The first interviews will be collaborations with four elementary classes in Canaan Schools, with following. Our first subject will be the closure of the Beecher Falls factory. I strongly encourage local people to interview their own family members and friends, with all training and equipment provided by the library. All interviews will be made available on a website and archived afterwards to make them available to a wide audience. Please contact us for more information.

Our library two robotics teams have started their challenges. First Lego League features 4th and 5th graders designing, building and coding Lego robots to complete given tasks and compete against other teams at a competition in December. First Tech Challenge involves middle and high school students doing the same with real aluminum robotics parts. These were funded initially by grant and donations from the New Hampshire FIRST organization.
