The second quarter of 2015 has been a mixed bag of good and bad news for us. The quarter saw a couple of our members fall and fracture a hip. Sickness and instability have also been prevalent for this Spring. Discussions about sharing the carriage house with the Alice Ward Library and expansion of space have taken place. We have been involved in discussions regarding the maintenance of the building, which we feel should be priority number one. In late April, we co-sponsored a quilt show with the Library. Attendance at the show was good and we later received a number of donated quilts that had ties to Canaan families. We also had the "Canaan Corners" event on the 20<sup>th</sup> of June which followed the format of our previous Canaan sections meetings which was well attended.

A number of items and documents, in addition to the quilts, have been received this Spring. Some of the items will be shared with other historical societies as there is genealogical information for residents of neighboring towns. A partial, hand written, marriage certificate issued to residents of Canaan Hill in the late 1800s and an unidentified object are our most recent donations. The unknown item could be a cradle, child's bathtub, or even an animals food trough. It is made from one part of a trunk of a tree, has "handles", and is extremely smooth. We will post a picture on our Facebook page for an answer. The Facebook page has been well received and we have received many positive comments. New pictures or newspaper articles are added every week or two to keep people interested.

Our main project for the summer will be interviews of as many older residents and former residents of the area as we can schedule. The interviews will be recorded on weekends, edited at a later date, and a new DVD of life in Canaan hopefully available by Christmas. If you have memories of certain aspects of growing up in Canaan and the surrounding areas, please feel free to contact us at 266-3989 and we will try to schedule a date and place that is convenient and comfortable for you. Initial contacts with possible interviewees have been mostly positive. #### CANAAN & STEWARTSTOWN WASTEWATER TREATMENT PLANT

The construction of the upgrade to the Canaan wastewater treatment facility and all of the pump stations has been completed. The construction of the \$3.3 million dollar improvements project has been performed by Daniel Hebert Inc. of Colebrook, NH. The new facility went into operation in October and is functioning fully as designed at this time. The four- 40 year old sewage pump stations located in Beecher Falls and along Rte. 253 have all been completely upgraded as well. The upgraded pump stations are much safer for the operator and less costly to maintain as well. The new treatment facility structures are single story buildings versus the old 3 story below grade building. A new screenings and grit removal head works building will remove inorganic material which will lengthen the life of the other treatment components. A second building houses aeration blowers, disinfection equipment and an office/lab and all electrical controls. The final building houses the final disinfection tanks before the effluent is discharged to the River. The improvements project was designed by Leach Engineering Consultants, now Tata & Howard, Inc., of St. Johnsbury, VT and funded through a grant and low interest loan from USDA Rural Development. The buildings were designed with energy efficiency in mind including insulated concrete walls, high efficient low -E glass windows and a highly efficient wood pellet boiler system. The 3 cell lagoon system has been upgraded with new aeration system and is performing well with an improved effluent being discharged to the Connecticut River.

#### WATER SYSTEM IMPROVMENTS- FIRE DISTRICT#1

The Canaan Fire District #1 water system improvements are in the design phase and it is anticipated that work will begin in August and be completed by the end of 2016. The improvements will consist of replacing many of the old small AC water mains with larger main lines which will provide fire protection, a new storage tank at an elevation that will provide increased pressure, connection to the Beecher Falls water system and a small treatment facility that will remove iron, manganese and other minerals from the water to improve the quality. The connection to the Canaan Fire District #2 system along the old rail bed will provide redundancy for both water systems. The water mains will be replaced on Rtes. 253, 102, 114, Ethan Allen Drive and Power House Rd. The State of Vermont Dept. of Transportation will be repaving all of these roads next summer. A new storage tank will be constructed on the Town Forest property. The Fire District will continue to provide water to Stewartstown. The project is being engineered by Tata and Howard of St. Johnsbury and will be publicly bid. The project is funded by USDA Rural Development. The project will completely upgrade the system.

#### **CANAAN FIRE DISTRICT #2**

Due to the reconstruction of the bridge in Beecher Falls/Stewartstown, NH planned to begin this fall, the District is faced with relocating the 8-inch water main from the bridge to a new location under the Connecticut River. The work is anticipated to begin in August.

#### SOLID WASTE UPDATES

In order to meet the requirements of Act 148 we were required to resubmit our Solid Waste Implementation Plan to incorporate all the new requirements. We were fortunate in that we are already doing most of the new requirements. Many towns are struggling to meet these new requirements. There are timelines in our SWIP that we are required to meet. Our biggest issue we need to address is composting. We need to get all food wastes out of our waste streams by 2020. We will be working on meeting this goal as well as the other timelines that are outlined in our SWIP.

Our new SWIP has been pre-approved. The new SWIP is on our website and a copy can be reviewed at the town office. We will be holding two public meetings which will be announced. These meetings are required for us to get our final approval.

Household Hazardous Wastes/Conditional Exempt Generators. (HHW/CEG) We submitted a new plan to hold HHW/CEG collection events at the transfer station instead of the town garage. We have worked with the Agency of Natural Resources to amend our SWIP to allow us to hold the events at the transfer station. This will allow us to hold an event in the Spring and one in the Fall as required by ANR and meet the requirements of our SWIP. We requested that they allow us to hold a spring event and hold the materials in a protected secure area in the recycling building and after we have our fall event we will contract with a licensed hauler to package the collected materials and ship off site to a licensed recycler. This operational change will reduce the cost of providing these events.

ANR has pre-approved our management plan to meet our needs and their standards. This will be an amendment to our SWIP.

Our draft plan is on our website and a copy can be reviewed at the town office. We are required to place a public notice in a local weekly newspaper. This is to allow for public comments on our plan. Comment period will run for 14 days. After the 14 days the state will determine if our management plan will get final approval.

It has been a challenge meeting all the requirements getting our SWIP completed. The state worked with us to meet these challenges and they offered some options for our HHW/CEG events that meet our needs and theirs and will reduce our costs overall to provide these events.


# Heart & Soul STEP-BY-STEP

If you are working in your community and initiating a new process, you can use this guide to structure your approach to community outreach, participation, and decision making. The Heart & Soul process described here begins with the earliest stages of

project development. It then moves into start-up activities such as project design and partnership development. From there, it walks all the way through to choosing actions and following through for success over the long term.

The whole process is outlined in 12 steps, each with a short list of specific tasks. The steps are organized into four phases that lead to specific milestones.
