
2022 GREEN UP DAY IS MAY 7!

DOG LICENSES





Per state law—all dogs 6 months or older are to be licensed every year.

Please bring in your most recent rabies certificate.

If you no longer own your pet contact the Town, so your name will be removed.

If you do not by that date the Animal Control Officer will pay you a visit.

CLEANUP OF EXCREMENT

Responsibility for cleanup of excrement. The owner of any animal shall be responsible for the prompt removal of any excreta deposited by his or her animal(s) off the owners premises. Failure to remove such excreta shall be considered a violation of the ordinance. The fine for a violation of this section of the ordinance shall be \$50 with a waiver fee of \$25. A written warning shall be issued for the first violation of this section of the ordinance.

LEASH LAW

Responsibility for Leash Law: "At large" shall be intended to mean off the premises of the owner, and not immediately under the control of the owner or a member of the immediate family either by leash, cord, chain or otherwise. Failure to follow the leash law shall be considered a violation of the ordinance.

WEIGHT LIMITS ON TOWN ROADS

There is a weight limit on town roads. We have the permits at the town office that you can fill out for waivers. The cost is minimal in that it is \$5 for a truck and \$10 for a fleet. This way if you are stopped on town roads you will have proof of permit. Contact the town office to get the information.

Why you shouldn't discharge your sump pump into the sewer system

When it comes to plumbing, there can be a fine line between finding the easiest solution and exploiting a shortcut. An example that comes to mind is the method for discharging a sump pump. Some homeowners connect their sump pump to a nearby drain and never give it a second thought.

While it may seem simple and harmless to discharge your sump pump down a regular drain in your home, it's actually a bad idea to send that water into the sanitary system. On top of potentially being illegal, this method can overwhelm the sewage system and cause other issues.

- 1. It may be illegal. In our municipality as in most connecting a sump pump to the sewer line is a big no-no. You could be fined for each day that your sump pump is illegally hooked into the sanitary sewer in some areas.
- 2. Overwhelming the sewage system. During a heavy rainstorm, the volume of water that sump pumps can move is more than the municipal sewer system and water treatment facility are designed to handle. If the sewer main gets overwhelmed, then wastewater can get backed up into your sewer line (under the property) or even into your home. This can result in a giant mess and health hazards.
- Environmental impact. When water treatment facilities are overloaded, they can dump sewage or only partially cleaned water into local water outlets, which is harmful to the environment.
- 4. **Issues selling your house**. If you're looking to sell your home and your sump pump is incorrectly hooked up, it may get flagged during a home inspection.

How to properly discharge a sump pump

There are two acceptable methods for discharging a sump pump. You can have the discharge pipe empty onto your property at least 10 feet from the home. With this approach, make sure the ground slopes away from the foundation and the pipe stays clear of debris or animals.

The second option is connecting the sump pump to the storm drain, which is separate from the sanitary sewer system. This approach usually requires professional installation but completely removes the water from your property.

PROCEDURE FOR FROZEN METERS AND OR BROKEN LINES

Section 6A. <u>Procedure for Frozen Meters and or Broken Lines.</u> The homeowner is responsible for the water service from the water shut-off to the home which includes the water meter. If a water meter breaks due to any occurrence, including freezing, it is the homeowner's responsibility.

These steps should be followed if an incident occurs:

- 1. Shut off the water as it enters the house if there is a working valve. If not successful, notify the Water Operator at 802-266-7723 to schedule having the water shut off at the curb stop. If possible, someone representing the property should be present when this is performed.
- 2. Contact the Water District for a replacement meter or frost plate if the incident is related to a frozen meter. The Water District will furnish a water meter for a fee, and you will be invoiced.
- 3. The water meter must be installed by the District's Water Operator. Under no circumstances will meters be permitted to be installed in any other fashion.

Bears Are Awake



As the snow melts and the weather warms, bears are waking up hungry.

- 1. Take down any birdfeeders or suet.
- 2. Store garbage and food scrap collection containers in a building if possible. Use other strategies to deter bears as needed.
- Backyard compost in an enclosed container that would be challenging for a bear to open and use lots of browns to cover any smells. If you have a bear visit, immediately stop composting in your yard and bring food scraps to a local drop off.

FROM THE LISTERS

NEMRC has completed a reappraisal of all real property in Canaan as of April 1, 2022. Over the past year they have inspected the properties and entered the information into a computer assisted mass appraisal (CAMA) system. Many changes in property values have occurred since the previous reappraisal, and many properties have undergone substantial physical changes. The purpose is to get the reappraisal of the properties to what value your property would sell for in today's market. The last Reappraisal was in 2008.

Official Change of Appraisal Notice booklets will be mailed at the end of April. Every effort has been made to equitable assess property in Canaan. Please compare your property with similar properties and with properties that have sold over the past three years. Information about the Hearing Process and Formal grievance hearings will be included in the booklet.

ANNUAL VERMONT HOMESTEAD DECLARATION

By Vermont law, property owners whose homes meet the <u>definition of a Vermont homestead</u> must file a Homestead Declaration annually by the April 15th filing deadline. If eligible, it is important that you file so that you are correctly assessed the homestead tax rate on your property.

Please remember to file both the 2022 Form HS-122 Homestead Declaration and 2021 Schedule HI-144 Household Income before the April 15th filing deadline.

In Vermont, all property is subject to education property tax to pay for the state's schools. For this purpose, property is categorized as either non-homestead or homestead. A homestead is the principal dwelling and parcel of land surrounding the dwelling, owned and occupied by the resident as the person's domicile.

All property is considered *non-homestead* (formerly "nonresidential"), unless it is declared as a *homestead*. The education property tax rate levied on non-homestead property differs from the rate levied on homestead property. It is your responsibility as the property owner to claim the property as a homestead if you meet, or expect to meet, the following requirements:

- You are a Vermont resident
- You own and occupy a homestead as your domicile as of April 1, 2022

Please note: If you meet these requirements, except that your homestead is leased to a tenant on April 1, 2022, you may still claim it as a homestead if it is not leased for more than 182 days in the 2022 calendar year.

NONHOMESTEAD PROPERTY

Property is considered non-homestead if one of the following applies:

- *Your property is leased for more than 182 days out of the calendar year.
- The property is used exclusively for a commercial, including rental, purpose.
- ◆The property is used for a second home, camp, vacation, or summer cottage.



Note: The Board anticipated a \$0.0173 cent increase on March 14th, but on March 15th the reappraised grand list was announced with the new CLA at 100%, along with the Ways & Means Committee Bill for a new yield, changing the estimated increase once again.

What You Need To Know About the 2023 Budget

Dear Canaan Community,

Our proposed budget presented to the community at our Annual School District Meeting on February 28th was not approved on the floor. There were 21 votes in favor and 24 votes against. We have listened to those who have shared cost cutting ideas and revisited the budget. What you see before you is a well-thought-out budget that meets our key priorities with the least amount of tax burden to the community and without limiting programs for our students.

The budget reflects our commitment to putting children first. We have prioritized an expanded

all day Pre-K program to support working families and to provide necessary early education interventions (\$98,519) for children ages 3-5. We continue to provide college credit Running Start courses and Industry Recognized Credentials (IRCs) for both our college and career bound students. We anticipated another year of increased enrollment in our hands-on Building Construction and Restoration program and have budgeted an additional part-time position and supplies (\$52,464) to not limit the number of students who can participate. We estimate our projected equalized pupil spending to increase by 6.01% compared to the current year. However, we felt these are necessary investments that will serve our students and community best.

Overall, the proposed FY2023 budget will be \$4,518,062, an increase of \$489,881, or 12% from the current year. The proposed budget also includes tough fiscal decisions. As has been the case over the previous year, we continue to tackle significant economic pressures due to the inequitable funding based on an outdated pupil weighting formula, increases to our student special education and non-special education costs (\$233,015), increase in negotiated salaries and benefits and operational and financial challenges caused by the uncertainty of COVID-19.

Your vote matters, so please do your part and cast your floor vote at the Canaan Memorial High School Gymnasium at 6:00PM on Wednesday, April 13, 2022. Your ongoing support helps us address the immediate needs of our community and set a long-term vision for Canaan Schools! We look forward to your support and your continued partnership as we work together to educate students to become lifelong learners in an ever-changing world.

Understanding the Tax Increase

Public schools are funded in part through residential property taxes. Some communities have higher property values, so the legislature designed the Common Level of Appraisal (CLA) to ensure all districts contribute their fair share to the Education Fund. Houses in Canaan have been selling for more than their appraised value, leading to a drop in the CLA. As the CLA goes down, the local residential property tax rate increases because homes are worth more money than their appraised value. When we revised and approved the new proposed budget, the CLA in Canaan was 106.11% resulting in a \$0.01 tax increase compared to the prior year. On March 15th, the Canaan received their Grand List 2022 Reappraisal Confirmation and adjustment of the CLA to 100%. On a positive note, the legislation is looking to approve the property yield at \$13,472. These are both unrelated to education spending, but will result in an estimated \$0.05 tax increase compared to the prior year. Public schools are also funded by state sales, use, meals, and rooms taxes. This year these revenues to the Education Fund are projected to be very healthy, which is why the Canaan Board is able to propose a budget with a 12.2% expense increase and property tax payers will only see a 3% increase in tax rates.

To qualify for Property Tax Credits, total taxable and nontaxable household income must be \$136,900 or less. More info at tax.vermont. gov/property/tax-credit,

Understanding the Floor Vote

On March 14, 2022, the Canaan School Board approved a budget of \$4,518,062 for the Fiscal Year 2023 (FY23). This represents a spending increase of 12% over the current year's budget. The current state formula with the new proposed yield and CLA estimates a 3% tax increase. Approval by voters would allow the school board and administrators to continue providing high-quality instruction that ensures all students graduate from Canaan Schools college and career ready.






