TOWN OF CANAAN PARKING BANS



Effective December 1, 2022 through April 1, 2023 between the hours of 11:00 P.M. and 7:00 A.M. it is unlawful to park on all streets and roads in Canaan and Beecher Falls (this includes Town Roads and Vermont Routes 102, 114 and 253).

SNOW REMOVAL

No person, other than an employee in the performance of their official duties as authorized by the Agency of Transportation or the Selectboard, shall plow onto the traveled way, shoulder or sidewalk of a State Highway or a Class 1, 2 or 3 Town Highway (V.S.A. T23 Section 1126a.)

NOTICE TO RESIDENTS

The Canaan Selectboard would like to remind Town residents that, despite the best efforts of the Town road crew not to do so, sometimes items within the Town highway right-of-way get damaged, either by snow removal or other highway maintenance equipment. The Town is not responsible for damages obtained within this 25 foot from center of road. The Selectboard is asking that residents beware before leaving or placing objects such as vehicles, fences, trees, signs, etc. within these boundaries. Objects may be removed at the owner's expense.

SELECTBOARD QUARTERLY REPORT

This has been an eventful year for the selectboard and here is a review of what has been accomplished in our little Town and what is coming up in the next year. First we would like to thank Peter Bunnell and the Canaan AIM Program for helping us install our new lettering above the office building. It looks great! Now let's look at some of our accomplishments this year.

For the highway department we completed a better back roads project on Canaan Hill and fixed ditches and the road by the bridge along with replacing the guardrails on the bridge. This was done with grant money from the state. Costs have gone up on everything so our budgets will be showing that. The backhoe was paid off this past year and the only piece of equipment we are left paying for is the newest truck. Vermont DOT notified us of the fact they are repaving from Norton through Canaan next year which will require the raising of all our manhole covers which is another added cost for next year.

We have applied for another back roads grant for next year and hopefully we get it. The bridge over Hall Stream is due to be worked on next year hopefully but that is still in the works of being decided between the state, engineers, contractor, and Town. Paving is set to be done through DOT grant on River Road after we take care of the bridge the year after.

The Town reappraisal was finished over the last year, and we should be all set for a few years on this level.

What this Town needs are people to step up and fill positions in the Town. On the back of your Town reports is a list of committees and positions that need people to fill them so our Town will run smoothly. People who have been manning these positions for years are getting tired and we need new blood in these positions. There will be an opening on the selectboard this year for three-year position.

SOLID MATERIALS

Your private or municipal system can process only toilet paper, which is designed to fall apart rapidly.

Never flush household solid waste such as paper, cloth, or plastic film, even if the package says it's "flushable." Those "flushable" wipes are a leading cause of serious clogs - never flush them!

These items don't dissolve. They mix with fats, oils, and greases, creating clogs that require costly repairs. They can also cause sewage overflows into rivers and lakes.

SOLID MATERIALS DISPOSAL

Toss household solid waste materials into the trash for pickup, or take them to your municipal drop-off. Don't try to burn or compost them (except food scraps)!


Food scraps also cause clogs -- and in-sink disposals don't help! Compost them if you can. Vermont law requires that by July, 2020, all food scraps be diverted from landfills to uses like composting and bio-digestion. Your trash hauler will facilitate.

NEVER FLUSH

The following common household items should never be flushed:

- · Paper towels
- Disposable diapers
- Tampons & applicators
- Sanitary napkins
- Hair
- · Rags
- Dryer lint
- Cleaning/disinfectant wipes
- Cigarette butts
- · Q-Tips
- Dental floss
- Bandages
- Condoms
- Cotton balls
- Facial tissues
- Flushable wipes
- Candy wrappers

CANDY



FATS, OILS, & GREASES

Never pour fats, oils, or greases (a.k.a. FOGs) into sink, toilet, or storm drain!

When they solidify, FOGs impair performance and require pumping or replacement of small septic systems. FOG clogs in public sewer pipes and pumps cause breakdowns that result in ewer overflows and costly repairs. Either way, you pay.

FOGs combine with solid materials - see opposite side - and create "fatbergs." These horror-story clogs cost New York City taxpayers \$20 million a year. Some towns in Vermont pay up to \$40,000 in avoidable cloq repairs

In-sink disposals do not dissolve FOGs!

Don't put FOGs into compost. They can attract pests and slow the composting

For more information on damage caused by clogs, do a web search for "fatbergs" lots of wonderfully gross videos!

FOG SOLUTIONS

Bacon Grease & Deep-Fry Oil:

- · Save in a jar and re-use. Do a web search for "what to do with bacon grease" for great food recipes and advice on how to make soap, candles, lip balm, bird food, and more.
- · Let cool until solidified, then wrap and dispose of in your trash.
- When warm, pour into a sealable jar or directly into your trash bag among absorbent materials.
- Wipe warm pans with a paper towel before washing; toss towels in trash.

- Use paper towels and dispose of

VERMONT ELECTION LAWS

Vermont Election Laws no longer requires Vermont Towns to hold a yearly nomination caucus: The sole purpose of which was to have a candidate for each vacant office.

Interested candidates wishing to run for election as a Town Official must get a petition at the Canaan Town Clerk's Office. The petition must be signed by 1% of the legal voters of the Town of Canaan. (This is about 8 signatures)

The petition form must be submitted to the Town Clerk's Office no later than 5:00 P.M. on January 30, 2023. If you are interested in seeing your name or someone's name on the ballot, please do not hesitate to pick up a petition. Each person nominated to run, must accept their nomination with the consent form on page 7.

Household Hazardous Waste (HHW) Collection in Vermont



Household Hazardous Waste (HHW) is the most toxic part of the solid waste stream and would be considered federally regulated Hazardous Waste when the waste is produced by nonresidential waste generators such as a business, school, or institution.

HHW includes common waste products labeled "caution, toxic, danger, hazard, warning, poisonous, reactive, corrosive, or flammable" such as:

- Aerosols
- Automotive additives
- Flammable degreasers
- Flammable lubricants
- Flammable liquid adhesives
- Furniture strippers
- Glues and adhesives

- Grout/Masonry cleaners
- Hazardous cleaners
- Hobby and craft supplies
- Kerosene
- Lighter fluid
- Mineral Spirits
- Paint thinners

- Paint and varnish remover
- Pesticides
- Pool and hot tub chemicals
- Rust remover
- Tar and bug remover
- Turpentine




Figure 1. Londonderry Solid Waste Group HHW Costs

For more than 30 years, Vermont municipalities have been required by law to collect HHW, however costs for one day collection events have increased as much as 50%. Some towns are spending \$100-\$400 per carload and an average of \$1.6 million per year (according to DEC's survey data) to protect human health and the environment (see Figure 1. for example, cost increases).

This is solely the hazardous waste contractor costs for a single collection event in June of each of these years without associated costs of advertising, labor, mailing, etc.

A shrinking pool of service providers coupled with both labor and supply chain shortages have forced solid waste districts and towns to spend more, or charge users more, to continue to provide these vital services. Charging customers more for doing the 'right thing' can lead residents and businesses to dump harmful waste in their trash or worse, illegal dumping. This threatens the health and safety of solid waste haulers and facility operators, contaminates landfill leachate, and can harm the environment.

Extended Producer Responsibility (EPR): In 2022 H115 was introduced to create a safe collection program for HHW, funded by HHW product producers—commonly called an "extended producer responsibility (EPR) program." The following 20 producers are estimated to produce about 60% of Vermont's HHW¹:



Vermont's five (5) existing producer responsibility programs provide free and convenient collection, recycling, and safe management of dangerous and difficult to recycle materials including: mercury bulbs, mercury thermostats, electronic devices (TVs, computers, printers), paint, and batteries. These programs successfully reduce municipal costs and result in some of the highest collection rates in the country.

For example, as the only state with a primary battery producer responsibility program, Vermont recycles more batteries per-capita than any other state (see Figure 2.).

CANAAN STUMP DUMP

The Selectboard would like to remind all residents that the Canaan Stump Dump closed on October 29, 2022. The Stump Dump will open temporarily on the first two Saturdays of January 2023 (January 7 & 14). The Stump dump will be open from 8:00 A.M. to 12:00 P.M. to facilitate the disposal of Christmas Trees and other clean wood products. This includes the brush from wreaths, kissing balls, and swag, as long as all metal, plastic, Styrofoam, etc., are removed. After these two days, the Stump Dump will remain closed until Saturday, May 6, 2023. Any dumping of any kind at the Stump Dump during this time frame is prohibited. If caught doing so punishment will occur in accordance to the Town of Canaan's Ordinance Regulating the Collection and Disposal of Solid Waste (Article VI Section 1 and 4)

Update on the Disposal of Appliance Containing Freon

The last newsletter contained erroneous information about the disposal of appliances containing freon. At the time it was the Selectboard's understanding that, following the program presented in October's newsletter and on the website, the residents of Canaan and Beecher Falls could dispose of these appliances at the Coos County Transfer Station. The Selectboard later found out that the County Commissioners were not comfortable with this endeavor. The Selectboard is working diligently to contact NRRA and find a new avenue for the disposal of these appliances. Until further notice, appliances containing freon can not be disposed of at the Canaan Transfer Station. If you need to dispose of these appliances, you must contact a licensed plumber to remove the freon and certify that it has been removed. Once you do that, you can dispose of them at the Canaan Transfer Station. The Town apologizes for any confusion or difficulties this has imposed on you. Even the best laid plans sometimes fail. Once the Selectboard has found an alternative means of disposal, the Town will notify all residents.

Meet Rural Community Transportation (RCT)

RCT is a nonprofit 501(c)(3) corporation which provides public transportation services throughout Caledonia, Orleans, Essex and Lamoille Counties. RCT operates fare-free shuttle and commuter bus routes, allowing connections between towns in our region and the ability to travel throughout Vermont and beyond. RCT also provides demand-response transportation services under several programs, such as Medicaid, the Elderly & Disabled program, and Rides 2 Wellness.

RCT runs four commuter routes to enhance access to employment, connecting Morrisville to the towns of Barre and Waterbury, and St. Johnsbury to Montpelier and to Littleton. We operate three shuttle routes tying Morrisville, Newport/Derby, and St. Johnsbury/Lyndonville residents and nearby Vermonters to essential locations, from grocery stores to medical centers. Shopping routes provide similar service spanning Morrisville and Stowe in the west, Newport and surrounding towns in the north, and Lyndon to New Hampshire in the east. In FY2022, RCT provided 979 rides to 20 residents of Canaan and Beecher Falls, traveling 41,917 miles at a total cost of \$24,957.61.

RCT operates with federal and state funding; however, our funding sources typically require between 20% and 50% locally matched dollars. All town appropriations received are used to provide the required local match and are therefore crucial to RCT's operations. Your generosity allows RCT to transform your funding into the ability to thrive, grow, and provide your community with reliable quality transportation service.


We had our first since Covid Wassail Party on the 16th of December and had a good time, although we didn't have the crowd we've had in the past.
