

The third quarter of the year has been a fairly busy one for us. In late June, we started interviewing some of the older residents and former residents of the town for their thoughts about growing up in Canaan. The process continued through the summer months at various locations. Our last interviews should be done by the end of September. Editing of the more than twenty hours of individual interviews will begin in October and we hope to have the final video ready by Christmas. Thanks to the Neil & Louise Tillotson Fund of the New Hampshire Charitable Foundation for the grant which funds the project.

On August 1st, we attended Barnet, VT's, 100th anniversary celebration of the last long log drive on the Connecticut River. The event was a huge success and our display of logging tools and pictures of the Connecticut Valley Lumber Company was well received. We had an enjoyable day answering questions about the artifacts and pictures.

We continue to receive donations, both monetary and display items. A WW II army uniform worn by Harry L. Kingsley along with a small journal he kept is one of the newest additions to our military collection. Old tools, pictures of The Beecher Falls Line House, Bouchard's gas station, the Spa, a 1956 North Country telephone directory, and a number of family and organization quilts have all been donated in the last months. We also received a video showing an initiation parade, a 4th of July parade from 1954, and other aspects of the area during the 1950s.

Our plans for the coming months will be discussed at our September meeting.

We now have new Canaan Historical Society hats for sale.

Check out our Facebook page. We try to add one or two new pictures a week to remind people of what Canaan and the surrounding area was like decades ago. We have received a number of complimentary comments and appreciate the attention the page brings to our organization.

Flushable?

A message from Canaan Wastewater Treatment Facility

Think again...

What we put down our drains and toilets can negatively impact our environment and put our health at risk. Even items labeled flushable can clog pipes, tangle pumps and result in messy and costly sewer backups. By educating ourselves and each other, we can avoid expensive and dangerous mistakes while improving our sewer system practices.


Steps we can take

There are only two items that we should ever flush: human waste and toilet paper. If you cannot avoid purchasing and using items that have been labeled "flushable," throw them away after use rather than putting them into our sewer system.

How this has affected our system

In the past month, we have had to hire a septic hauler to pump and pull out the pumps three times to remove rag like debris. That same pump station located at the end of Hall Stream Road needs to be serviced again. Every time this happens it cost at least \$400 and is very time consuming. There is no easier way to fix this issue and during the time it takes to schedule it, one of the two pumps is down at the affected station.

- Baby wipes, disinectant wipes, moist wipes, etc.
- Vitamins, medicines or other pharmaceuticals

Solid Waste Update

We held our first HHW Event at the transfer station on July 2. The event went quite well and it proved to be more convenient. The new secure collection area that was constructed at the recycling building was able to handle all the materials dropped off. Our next HHW collection event is schedule for Oct. 3rd. at the transfer station 8:00 AM to 1:00 PM. There is information at the recycling building, town office and our town website, (canaan-vt.org) on what HHW materials can be accepted at this event. There are no fees charged for the materials collected. These events are for Canaan Residents Only. Clean Harbors is scheduled to pick up the materials collected from the events on Oct 6th.

We were asked by the Agency of Natural Resources and the Town of Lemington if we (Town of Canaan) would consider letting Lemington residents use our HHW Events. The selectboard reviewed the request and agreed that we could handle having Lemington use our HHW Events. A mutual agreement was written and signed by the selectboards of each town.

The current agreement starts for the calendar year 2016. The agreement will be reviewed each year to make any adjustments needed. The towns of Canaan and Lemington will each pay half of the costs for the hauler and labor needed to manage these events. Both towns will pay for the materials collected from their residents. Sign off sheets will be maintained for both towns. HHW materials collected from both towns will be kept separate and each town will be responsible for the cost of the materials collected from their residents. These costs will be for packaging and for the recycling/disposal costs of the HHW materials. This arrangement will help reduce the cost of providing HHW Events for both towns.

On another issue we have set up cameras for the security of the Transfer Station and the Wastewater Treatment Plant. We recently had an attempt to break into the office at the Transfer Station. All collected fees are dropped off at the Town Office each day. No money is kept at the Transfer Station office.

We have had several occasions when people have used the Transfer Station when it was not open for the disposal of recyclables and trash. This is considered illegal dumping and fines could be imposed on anyone caught using the Transfer Station when the operator is not on site. Sometimes the access gate to the Transfer Station is left open when the Treatment Plant operator or septic hauler is on site working. An open gate during unscheduled hours for the Transfer Station doesn't mean there is legal access to the Transfer Station. We are required to maintain a secure site as part of our Solid Waste Implementation Plan.

We did have representatives from the Agency of Natural Resources visit our site and they were pleased with what we have and didn't have any concerns that we need to address. As part of our SWIP we will need to address keeping food wastes out of our waste streams, provide recycling containers at public events and public facilities. We are also required to send out surveys related to all requirements of Act 148. We are in the process of meeting these requirements.

Community Revitalization Committee

We have changed our committee name from (CEDC) Canaan Economic Development Committee to (CRC) Community Revitalization Committee. Progress is not always as fast as we would all like it to be. We have been working about a year and a half to build a foundation for this committee to move in a direction that meets what we had initially set as goals.

It became clear early on to the group that in order to change conditions in this region and truly identify and tap into the opportunities that exist here, it is critical that those who will be most impacted be engaged in the process. With real engagement of residents, businesses, and visitors from the area four things will happen: 1) we'll have an accurate and distinctly local communication of the opportunities that exist and tap into them, 2) we'll begin to dispel the sense of hopelessness and decline in the area as those who live, work and visit here begin to really feel and know that "something good is happening" because they are part of it, 3) we'll have buy-in and help in spreading the word as local residents, business owners, visitors start talking about it to others, 4) That we "CAN": GET SOMETHING GOING (travel/tourism/community gatherings/events, GET THE WORD OUT (the draw of the area), GET PEOPLE WORKING (labor and business).

The above was a compilation of discussions and ideas at our initial meetings. I want to give credit to Lu Vanzealand for her help in facilitating the initial meetings and providing minutes for which the above was extracted. Lu was working in the area for the summer and volunteered her time and expertise in this field. Lu was not able to continue in this role and it was evident that we needed this kind of knowledge to continue and meet our goals and expectations.

We applied for a grant to hire a facilitator/ coordinator. We received a grant from the Tillotson Foundation to help with this process. We have met with organizations and potential facilitators that could help us reach the next level and to meet our primary objectives.

We have interviewed a facilitator and are in the process of signing an agreement.

NVDA provided a representative to work on this project. <u>Joe Kasprzak</u>. Joe is now the assistant town manager in St. Johnsbury.

NVDA will be helping the town with updating the Town Plan. This will take place in 2016.


